1. Each exhibitor will get one registration for the conference.
2. Exhibition hours are: Thursday July 4, 2013 5:00PM – 10:00PM, Friday July 5, 2013 9:00AM – 10:00PM and Saturday July 6, 2013 9:00AM – 10:00PM.
3. Allocation is on first come first serve basis. Booths will be allotted upon payment only. Space is not guaranteed until payment is received
4. VPA Convention committee has right to refuse booth to anybody.
5. VPA Convention committee has right on final allocation of booths and changing the layout at any point of time.
6. Neither conference organizers nor the convention center shall be responsible for loss or damage occurring to the exhibits from any cause. No Insurance will be provided by VPA or Conference Center. If insurance is desired the exhibitor must obtain it.
7. The Conference organizers – VPA and other participating organization officers and staff members disclaim all liability for damages or losses caused to any exhibitor by an act of god, or by fire, water, flood, windstorm, utility failures, and rodents, acts of vandalism, insurrection, civil disorder strikes, criminal act or theft. VPA organizers will not be responsible for any failure for electric or other services.
8. The Conference organizers – are not responsible for any immigration or customs issues.
9. All matters related to disputes will be settled through negotiation. If there are any legal disputes, the jurisdiction of the court will be in Illinois State, USA.
10. No nails or screws may be driven into the floor. No damage of any nature may be done to the booth structure or to any part of the exhibit hall.
