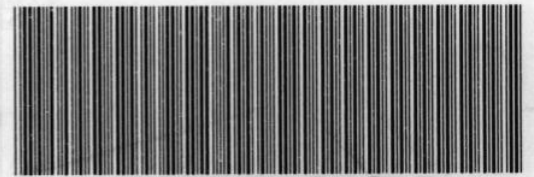

Article 5: Other Provisions:

Upon the dissolution of the organization, the organization shall, after paying or making provisions for the payment of all the liabilities of the organization, dispose of all the assets of the organization exclusively for the purposes of the Association in such manner, or to such organization or organizations organized and operated exclusively for such charitable or educational purpose as shall be at the time qualify as an exempt organization or organizations under Section 501 © (3) of the Internal Revenue Code of 1954 (or the corresponding portion of any future United States Internal revenue Law), as the Executive Committee shall determine. Any such assets not so disposed off shall be disposed off by Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for which purposes or to such organization(s), as said court shall determine, which are organized and operated exclusively for such purposes.
